**Procedures and Regulations for Candidates  
Bachelor of Arts in Communication Management (International Program)  
Faculty of Communication Arts, Chulalongkorn University  
Academic Year 2025 Admissions**

1. The interview for candidates to the B.A. in Communication Management (International Program), Faculty of Communication Arts, Chulalongkorn University, for the 2025 academic year (International Admissions), will take the form of an Analytical and Critical Thinking Test (ACT).
2. The ACT will be conducted in an **online, face-to-face interview** via Zoom.
3. **Interview Date and Time:**  
**Tuesday, May 13, 2025**  
**08:00 – 12:30 hrs. (UTC+7, Bangkok Time)**
4. **Candidates must prepare the following in advance:**
  - a) A communication device such as a desktop computer, laptop, tablet, or smartphone
  - b) A stable internet connection
  - c) The **Zoom Workplace Application** (download and install before the interview)
5. All candidates must **report and register** by submitting a **selfie with their passport** via the **LINE account** provided by the Faculty. The account information will be made available on the program's official website: [www.inter.commarts.chula.ac.th](http://www.inter.commarts.chula.ac.th).

6. The Faculty will provide a **QR code** to eligible candidates for adding the official LINE account. Candidates must add the account between **15:00 and 17:00 hrs. on Thursday, May 8, 2025**.
  7. After completing registration (as outlined in Sections 5 and 6), eligible candidates will receive the **Zoom Meeting ID and password** required for the interview.

8. **Cheating or dishonest behavior** during the interview is strictly prohibited. Any violation will result in immediate disqualification, invalidation of the interview result, and a **one-year ban** from applying to the Faculty.
9. All eligible candidates must complete registration and attend the Analytical and Critical Thinking Test (interview) at the specified date and time. **Failure to attend** will be considered a withdrawal from the application process.
10. The decision of the Admissions Committee is **final and not subject to appeal**.

## Rules for Analytical and Critical Thinking (ACT) Test

The ACT Test is designed to assess a candidate's analytical and critical thinking skills. It is an approximately **8-12 minute online, face-to-face interview** conducted via **Zoom Workplace**.

### All candidates must comply with the following rules:

1. Candidates must ensure they have the necessary communication devices, a stable internet connection, and the **Zoom Workplace** application installed. A stable and uninterrupted internet connection is essential throughout the test.
2. The ACT Test has a fixed duration and a specific number of questions. Once the timer expires, the test will automatically end, even if the candidate has not answered all the questions.
3. The ACT Test is an exclusive interview between the candidate and the exam committee. Candidates must ensure privacy during the test. No other individuals are allowed to enter or exit the room during the test.
4. The test will be conducted via the **Zoom platform**. Candidates must keep their video camera on for the entire duration of the interview. **Headphones, Bluetooth devices, and wireless over-ear headphones** are not permitted.
5. If the candidate's internet connection fails during the test, they may reconnect to the Zoom session. However, any lost progress cannot be recovered, and the test will continue within the predetermined time frame.
6. Candidates must ensure that no other software is running, and no other electronic devices are in use during the test.
7. Any form of internet search, accessing online sources, or receiving assistance from others during the test is strictly prohibited. Such actions are considered cheating and will lead to disciplinary action.
8. There will be no make-up sessions or time extensions for any reason.
9. The ACT Test is confidential. It may not be copied, posted online, recorded, or reproduced in any manner at any time. The exam questions and answers must not be disclosed to anyone during or after the test.
